
Adding Quality to Quantity

Fine-tuning your view of the market throughout the trading day.

Whether you see the glass as half-full or half-empty, our teams are making sure you know exactly what's left. In this release, we've introduced the **% Remaining Volume** condition for automated trading rules, allowing you to control which orders are automatically routed based on the order's size relative to the symbol's estimated remaining daily volume.

Your Market Minder windows get to benefit too, with new columns that help you better understand how your order stands in the market, such as the **Est. Remaining Volume** column that displays the estimated quantity of shares available to trade for the remainder of the trading session, and the **Order % of Remaining** column that displays the size of your order relative to the Est. Remaining Volume.

Swing on over to the Eze EMS 2022.1 release notes where you'll find a detailed explanation of all these columns and calculations, and see for yourself: just how full is that glass?





The Conditions Keep Coming

Creating clarity and confidence for trades in Eze OMS, you can use the Reconciliation Blotter module to view finalized trades, broker details, and broker matching details all within Eze Operations Portal. But it doesn't stop there, you can also set notifications to communicate the most up-to-date information from the Trade Blotter to third-party brokers for matching.

Right now, we're focusing on facilitating the broker matching process, but just you wait! The ability to force match will be coming your way in future releases, so keep an eye out!

Just a heads up: this blotter is currently only available for a subset of users, so make sure to check with your SS&C Eze client service representative to learn more.

Are you an Eze EMS/OMS Integration user? In this release, you'll find the new **EMS Order ID** field: a field dedicated to EMS/OMS Integration that stores and displays Eze EMS ID values. This may sound like a small change, but it has a huge impact, as it allows ExternalID to become the dedicated Eze Interface field.

What else does this allow you to do? You can now use Eze EMS/OMS Integration simultaneously with other types of trade automation, including Eze Interface and xAPI. Pretty cool, right?

A deep dive into gains and losses.

We're helping you turn knowledge into power. In this release, we've introduced the **Cash Gains and Losses** report, giving you an at-a-glance view of both realized and unrealized gains and losses on cash positions across your fund(s).

In this new report, you'll find features including multi-tiered groupings, with summaries and drill-down capabilities. You can also choose between two modes to display results. In Period Gain and Loss mode, the results are specific to the report date range. In Total Gain and Loss mode, the results are reported from individual trade dates to end reporting date.

Go ahead, roll on over to the Cash Management section of the Reporting suite and explore everything this exciting addition can do!





Providing a comprehensive look across reports.

We couldn't just stop there when it comes to cash gains and losses. In this release, you'll also find the **Summary Gains and Losses** report, providing you with a consolidated fund-level picture of the gain and loss details across the Cash Gains and Losses, Capital Gains and Losses, and FX Contracts Gains and Losses reports.

The Summary Gains and Losses report offers multi-tiered grouping options (e.g., by security type, currency, strategy, etc.), with each group's gain and loss totals at the fund level. These totals and sub-totals are the sums of the trade level details available in the other gains and losses reports. You'll find this guy in the Profit and Loss section of the Reporting suite. Go take a bird's-eye view.



Embrace the Repo changes as they come.

Change may be inevitable, but with Eze PMA, we're making sure you never stop growing, even as your Repos continue to change. In 2022.1, we've enhanced the Import Eze Amend step of the Trade Import procedure so that when Repo trades are imported with different forward dates, the Fwd Date column is updated, and the results are displayed on the Trade Blotter once the import is successfully completed.
