## A Special Delivery

No cash movement? No problem! That's exactly what Free Delivers and Free Deliver Shorts is here to help with.

Starting in 2020.1 Eze PMA natively allows you to handle Free Delivers and Free Deliver Shorts, while ensuring you can track the accounting impact of Free Deliver messages in PMA, and keep tabs on the movement of assets out of a fund when adjustments are required.

Free Delivers and Free Deliver Shorts can be added manually via the Trade Ticket and imported via the Trade Import procedure. All asset types are supported including Equities, Options, and Notional Contracts.

#### Zero's a Hero

In the Eze PMA 2019.8 Update Tour we talked about "Trade Through Zero" for Free Receipts. This important functionality is also available for Free Delivers.

A quick recap: if a short sell is entered when a long position exists, the long position is closed, and a short position is only created for the excess shares. This is the basis of "Trade Through Zero".

For Free Delivers, this logic applies for when creating Free Delivers or Free Deliver Shorts for which positions already exist in Eze PMA: the Free Deliver functionality closes or partial closes the position, and creates a new position for any remaining amount.
