While this release has a number of behind-the-scenes improvements, the big feature is our improved integration with Eze OMS. Read on to see what is ready for you when you upgrade to Eze EMS 2020.2.

#### Stay in Sync

#### We call it "EMS-OMS Auto Trade Sync", and it's a pretty big deal.

We've dedicated a lot of time making Eze EMS and Eze OMS work more closely, but this release introduces data synchronization that you just can't get between any other Execution Management and Order Management systems. It's only in Eze OMS and Eze EMS.

In the past, trade information could easily pass from OMS to EMS – which is great, but if you needed to make a change in EMS, you had to update Eze OMS manually. Starting in 2020.2, single-leg, M-state, trade-level data, and actions are passed from Eze EMS back to OMS.

#### Sounds pretty good, right? Wondering what this looks like in practice? Let's look at a scenario!

Imagine a situation where a Portfolio Manger places a buy order in Eze OMS, that is then passed to Eze EMS for you to work. You claim the order, and start working until you get a call from the Portfolio Manager. They're not at their workstation, ask you to increase the order by 200. No problem! You increase the order and, after having passed pre-trade compliance, know that your trade information is exactly the same in Eze EMS and Eze OMS.
