# In Control.

Automated or manual, the choice is yours.

Sometimes you want to let the car handle the gear changes, and other times you want to shift in the perfect gear for that upcoming curve – we think you should have the same level of control in Eze EMS. You can let our Automated Trading handle the shifting so you can sit back and cruise or use the manual tools and data so you can hit the apex, Eze EMS 2022.6 is the right tool for the way you want to work. Let's take a look at what this latest and greatest version has to offer you!



## Meeting your Approval

**Eze EMS Automated Trading is a huge boon for your executions – but you already knew that, you've been doing more with less overhead for a while now. We've added a couple features that both let you automate more, but also take some extra manual control too.**

Let's talk about automate more first: take a look at your blotter. Are there staged single-leg orders entered that, perhaps initially didn't meet your automated trading criteria (and as a result weren't picked up by Automated Trading), but now do? With the new **Evaluate for Automated Trading** feature you can have Eze EMS review the order and then send it to Automated Trading for processing if it matches one of your rules. Order still doesn't match your rules? That's fine, you can still execute the order manually as usual.

Speaking of doing things manually, sometimes some manual intervention is worthwhile. For example, when setting up trade rules, you want to add a step for manual review of auto-routed orders so you can make sure the rules are working to your liking. Just click the **Routing Approval Required** checkbox when making the rule and you're set with that extra level of control over your automated trades.

All that's left is to approve or reject the order routes, adjust the rule if needed and when you have the confidence your rules will behave exactly as you expect, turn off the manual review and let Automated Trading take your executions to the next level.



## Bid/Ask and You Shall Receive

**Keeping your data easy to evaluate is key in making the right decision quickly.**

Bid and Ask information is always key, and as someone who works on the sell-side you spend a lot of time in the Time and Sales window – double checking information that could have been better organized is frustrating and time consuming. That's why we've re-worked the configuration for the Time and Sales window to give you the option to consolidate the Bid and Ask data in the same row as its corresponding trade.



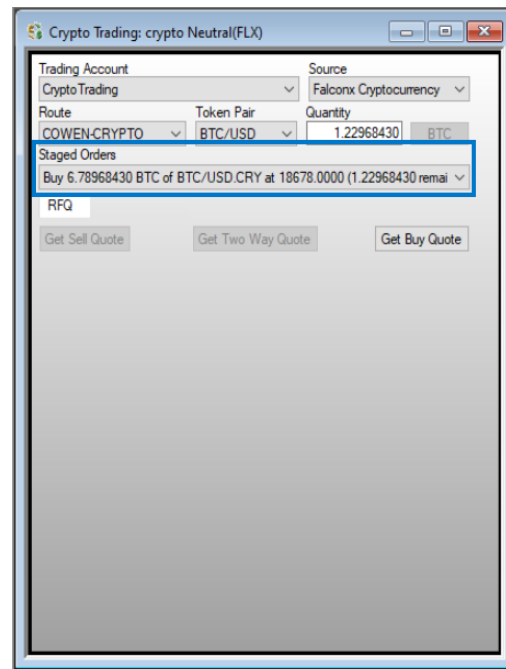
# Crypto, too

You didn't think we forgot about Crypto support in Eze EMS did you?

We'll talk about the cool integrated Eze EMS/OMS Crypto features on the next page, but that doesn't mean Eze EMS doesn't have bespoke crypto functionality in 2022.6! For starters, when selecting a staged crypto order from an order blotter, the associated order details are populated in the Crypto Trading window.

While we're in the Crypto Trading window let's talk about our second enhancement. Notice the new Staged Orders drop-down that helps you move through staged crypto orders quickly and find the specific order you're looking for, directly in the screen you need to be in.

## Trade Data in the Blink of an API

### The Operations Portal just got even better.

You've been able to receive DTCC Central Trade Manager® (CTM) data for Eze OMS trades for years now, but we've made two great changes you're going to like.

First, the CTM workflow is now performed via API, ensuring you can retrieve data in the real-time and make quicker trading decisions with the most up-to-date information.

Second, you can now access this integration in the Reconciliation Blotter module of Eze Operations Portal, making it even easier to access CTM data!

## Corporate Action

**Downloading Corporate Actions putting you in a spin?**

Corporate Actions have been split between two procedures: Corporate Action Download Procedure and Corporate Action Procedure via Service – the latter sometimes being a bit of a challenge to set-up. We've looked to make life easier in this release, meaning you now have Corporate Action Download Procedure as your one-stop shop for Dividends, Splits, Spinoffs, and Return of Capital (ROC).



## Don't Look Back (Days) in Anger

**We know the scene, you've changed trade details, and now you want to regenerate accruals without impacting existing settings.**

Eze PMA 2022.6 introduces Look Back Days to the Expense Accruals Generate Procedure. Now when you're in that situation where you need to regenerate accruals, you can tell Eze PMA how many days to "look back" from today's date to regenerate accruals. Why do all the rework when you just need to count back a few days?



## Always on the Trail

**The backbone of every successful accounting system is its audit trail.**
