Automate, Alert, Approve

It's Automated Trading again, but a very different workflow from the above.

We get it, you're playing it safe! That's why we've added in the ability to configure EMS to trigger an alert window for any automated trades so you can review and approve (or reject).

That's pretty good, but you can now also use the Percent of Ticket option for Hot Buttons to trade crypto, so you can now configure a hot button using a given percentage of a ticket to quickly buy or sell without needing the manual effort (or time) to fill out the complete order form!

Finally, our integrated Eze EMS/Eze OMS users can speed up pre-trade compliance and more by pulling fields such as OMS Manager, OMS, Trader, Custodian and more into the aforementioned RFS or RFQ trading tabs. Eze OMS — A Year in Review






Looking back on a busy year.

You can view and force match finalized trades and brokers in the Reconciliation Blotter, add, edit, and delete UDFs in the UDF Management module, manage broker data in the Broker Information, and view RESTful API documentation API Documentation module.

There are plenty of other bells and whistles in Eze Operations Portal in 2022, including Dark Theme, improved validation, enhancements for the FIX module, and more!



Repo the Benefits

We've added additional functionality to Repo Deal Manager so you can trade repo trades more confidently and efficiently.

Early in 2022, we made it so expired repos are automatically closed, allowing you to more easily identify active repos, filter the Repo Deal Manager grid, and archive expired repos.

We also improved repo Analytics functionality by making sure certain fields used for custom Analytics calculations and columns continue to updated after repo trades are rolled over, ensuring that calculations continue to update correctly after trades are no longer on the Trade Blotter, and that you can continue trading repos with confidence!



Getting the most out of your Eze EMS/OMS integration.


Eze EMS/OMS Integration has seen quite a few impressive features in this year's releases, from the ability to configure OMS-originated trade behavior for EMS cancels, enhancements for claiming synced trades, the ability to accept futures with negative prices, the ability to bypass EMS trade filter during synchronization, and last but not least, support for Crypto trading, including pre-trade compliance.

Eze PMA 2022.8

Always ready for the challenges ahead.


The job is hardly done when your trades hit the back-office: reconciliation, fees, allocations, reporting — the list goes on. That's why it's good to have a tool that's ready to face up to the next task ahead. Whether that's configuring fees, managing strategies, or anything else that your portfolio management and accounting processes may require, Eze PMA is ready for you. Let's look at some of the new features waiting for you in this latest version of Eze PMA.



Previously in Eze PMA, you could only add generic trade fee amounts, such as legal, commission, and audit to the system as a fixed fee via the Expense Prepayments and Accruals grid. A bit restrictive compared to Admin and Management fees, but we have some good news!

Eze PMA 2022.8 flexes its might with the introduction of the Fee Setup grid! Here, you can create fees, and define fee ranges and the basis on which the fee is calculated: percentage, basis points, or enter a fixed fee amount!

All fee accrual calculations use the NAV/GAV and you can schedule how often these are generated via the new Fee Wizard. The Fee Setup grid shown below displays the fees, fee ranges and associated fee details. A 'perfect fit' for however you need to structure your generic fee calculations!





The Long and The Short of It.

In this case "it" being sides when defining strategies.

The Strategies Attribute Definition grid now includes the ability to define a strategy as Long or Short! This makes it easier to correctly allocate P&L when manually processing trades, and help more easily identify positions as ether assets or liabilities!

That's not all though, when a new strategy is defined, Eze PMA automatically creates a corresponding strategy in the opposite direction, ensuring both sides of the associated trades are properly managed. Now that's the some long-sighted strategic thinking!



That is the question on the Position Reset grid.

You may already be familiar with the Apply Report Date Exclusion setting, as it's presently available on reports such as NAV Exposure, Positions, and Open Lots — but now it can be found on the Position Reset grid as well! Let's say you have a day with already created trades and you want to run a position reset, but not affect those created trades. With the Allow Report Date Exclusion setting, you just need to check boxes on the position reset grid and when you run the position reset, those trades will remain just as they are.

Closing the books on 2022

That's 2022 accounted for, now it's time to open the books on 2023. There's no time to waste as our teams are working hard to bring you all new features in Eze PMA 2023.2!
